

## Appendix A

### Instructions for Completing an Application for Cooperative Sponsorship

Rules regarding cooperative sponsorship can be found in the League's *Official Handbook*, Bylaw 403.00.

The governing boards of each participating school must jointly make application for cooperative sponsorship. Each school must obtain the **approval of their local school board** well in advance of the deadline indicated below.

#### Membership and Grade Level Eligibility

**Only MSHSL member schools** may form a cooperative sponsorship.

*For cooperative sponsorship information, click on Home/Publications/Official Handbook, Bylaw 403.00.*

Participation in League sponsored programs is limited to students in grades 7 through 12. Students in grade **7, 8 and 9 may participate only if they are enrolled in a continuation school for that high school.**

*For grade level eligibility information, click on Home/Publications/Official Handbook, Bylaw 105.00.*

#### Deadline

Requests for cooperative sponsorships must be submitted to the MSHSL office **not later than the first day of practice for that sport season.**

*For start dates, click on Home/Calendar/MSHSL Projected Calendar.*

**Home schools and Charter schools** joining the League and entering into cooperative sponsorship agreements after September 1 will be allowed a late registration provided they can show evidence from their local school administration that they had no knowledge of the MSHSL deadline dates, process, etc.

#### Activity Fee

**Each member school** participating in a cooperative sponsorship **must register and pay** as an individual school to participate in each cooperatively sponsored activity. Do not enclose payment with your form. **Each school will be billed.** The annual activity fee is **\$90**. After May 15, a **late fee of \$10** is added.

#### Completion of Form

Print the [Application for Cooperative Sponsorship](#) from the League website.

Enter the activity in which the schools will coop.

- Complete a **separate application for each activity.**
- Indicate whether it is a **boys' or girls'** activity.
- For **adapted activities**, enter the sport and the **division**, CI (Cognitive Impairment) or PI (Physically Impaired).

Enter the **school year** in which the cooperative sponsorship will begin.

- Cooperative sponsorship agreements must be for a **minimum of two years.**
- Cooperative sponsorship agreements will be continuous following the first two-year agreement unless an **application for dissolution** is submitted.

Enter your **school's** name, enrollment, city, administrative region, and current competitive section for this activity.

#1: Check Yes or No. **If yes**, each application for a cooperative sponsorship shall include a review and comments from the conference(s) of which the schools are members.

- #2: Check Yes or No. If **yes**, submit an Application for Dissolution of a Cooperative Sponsorship.
- #3. Enter the **purpose for sponsoring a joint team or activity**.
- #4. Enter a number or "0" for each grade, 7th through 12th  
for those students **who participated** in this activity the previous school year  
**OR**  
for those students **who will participate** in this activity when the co-op has been approved.
- #5. The official school identification in **tournament programs and press releases** for cooperatively sponsored teams will be listed as indicated on the cooperative sponsorship resolutions submitted by the schools.

**Signatures:** A member of each school's Board of Education, or each Board's designee, must sign and date this application.
